Cutting Edge Credit Union for TRBCH Meetings is our new official meeting location. (Approved at our Feb. meeting.) Cummings Creek Chapter Ride

Apr. 6, 9:30 am Ready to Ride. WDFW Discover Pass or Access Parking Pass is required.

Bring a lunch and hand tools for brushing. Easy water grade trail on an old roadbed. Typically we have to logout some trees and brush a little, but it is a nice place to ride. There is an old mine shaft to check out if you have never been there before.

Directions: Take Hwy 12 West to Pomeroy, continue through town about 2 miles, turn left on Tatman Mountain Rd. Stay on the pavement, keep right on Linville Gulch Rd. Linville Gulch continues up the canyon, turn right on Blind Grade. It turns to gravel in a short distance. Go down Blind Grade to Tucannon River Rd. a paved road and Turn left. On your right in about ½ mile you will come to a parking lot on the right just before you cross a bridge on the Tucannon River. There are hitchrails here. Cummins Creek Trail is straight across the road from the parking area. If you cross the bridge over the river, you went too far. Allow one hour driving time from Clarkston.

Idaho Fish & Game

Andrew Mackey, Wildlife Biologist, Craig Mountain Wildlife Management Area, was a guest speaker covering his proposal to improve access and awareness of trail opportunities on Craig Mountain. He has funds to hire a Montana Conservation Crew (MCC) for six weeks and hopes to have the trail identified better from Madden Creek to the mouth of the Salmon River. This trail is a combination of cowboy, sheepherder, and U.S. Calvary trail construction over the years that have been typically called the Mid-Elevation Trail. This trail connects to five IDFG cabins open for public use.

Redbird Trail Clearing Feb. 18th

Wow, what a change in the weather for our second trip to finish the clearing and brushing. Snow was deep enough that we were afraid to drive into the parking lot so we unloaded by the county road. We had a great crew clearing blackberries, Rod Parks, Carl Paulson, Rich (new member), Don and Ethan Klement, and Lorelei.
