TRBCH Guests: State Brand Inspectors

Kris Budde, Idaho Brand Board; Kayln Slaybaugh, Washington Brand Dept.

In Idaho any change of ownership requires a brand inspection. If you leave Idaho for any reason, an inspection is required. Kris Budde suggested Idaho stock owners get a lifetime inspection certificate which is accepted in most states. In Washington a bill of sale is adequate for an in-state sale. A brand inspection is required if an animal leaves or enters the state.

When buying a branded horse or mule always check with brand inspector first so you do not lose the animal to the owner of the brand. If you purchase a BLM animal always make sure the registration papers are in the correct owner's name.
